It has come to our attention that the Georgia Workers' Compensation Medical Fee Schedule, effective April 1, 2006, has sections where there were miscalculations of maximum allowable reimbursements (MAR) for some CPT codes. There are 13 CPT codes that were involved. In order to correct this error, Ingenix, the publisher and printer of our fee schedule, will print an erratum page that can be replaced with the current page of the codes that were affected and immediately mail to all of those who have received their new fee schedule. For those of you who have received your 2006 fee schedule in the CD format, a new CD will be forwarded to you immediately. All books shipped out in the future will contain the corrected reimbursements.

In the interim, please find attached a list of the affected CPT codes which shows the current MAR with the corrected MAR. We apologize for this error and any inconvenience it may have caused.
